



CERTIFICATE OF INSURANCE REQUIREMENTS FOR TEAM CART USE AND GOLF CART RENTALS

Coverages and Limited Required:

Team/Renter, at its sole cost and expense, shall obtain the following minimum amounts of insurance coverage:

- **Commercial General Liability Insurance:** This insurance shall provide a minimum Combined Single Limit of \$1,000,000 each occurrence with General Aggregate no less than \$2,000,000.
- Must include the “**GPALB Group**” entities shown below as Additional Insureds
- Insurance must be primary and noncontributory as respects any other insurance available to the additional insureds and waiver of subrogation must apply.
- Must note coverage applies for the operation of mobile equipment “pit vehicles” such as golf carts during the **2026 Acura Grand Prix of Long Beach**.
- **Commercial Inland Marine Insurance:** This insurance shall provide a Replacement Cost Limit of a minimum of \$15,000 per cart rented. **This coverage only needed if renting from GPALB.**
